- Japan Address Master
Maintained through Japan Post data feeds, our highly tokenized Japan Address Master services support heretofore unseen predictive input capabilities, filtering result sets based on not only successive post code input, but also address token name input (in any form of Japanese phonetics, kanji characters, and English).
- Japan Bank Master
Maintained through Japan Banking Association data feeds, our Japan Bank master services support predictive input filtering based on successive depth input of bank and branch codes and names.

These market microservices not only support dramatic improvement in a web application user experience, but also may be used as a service source to help manage a portfolio of related information (e.g., customer data, etc.) as master data points slowly move, for example, based on address and bank branch consolidations over time.
